SUPPLEMENTARY REGULATIONS

- JURISDICTION:** Open to all paid up members of the Normandy and Thames Motor Cycle Clubs and invited guests (subject to availability) riding solo machines.
The event will be held under the National Sporting Code, Environmental Code, Standing Regulations and Covid-19 Crisis Risk Assessment of the ACU Adult and Youth Division, regulations of the organising Centre, these Supplementary Regulations and any final Instructions which may be issued.
- ENTRIES:** Via ACU On-line system ONLY – limited to 60 riders - no day entries - no spectators – Opens 1st August Closes 16:00 on 22nd August or when full Adult £ 20:00, Youth £15:00
Note only **ONE** parent or guardian can accompany a youth entry
- COURSE:** Mountain Wood Farm, Green Dene, Surrey, KT24 5TA, please park ensuring social distancing rules are adhered to, (park 2m apart)
- MARKING:** Will be by the 0 - 1 - 2 - 3 – 5. **TSR22B NON-STOP** Marking system will be used. All queries are to be taken up with the Clerk of the Course whose decision will be Final. Scoring will be by individual score cards issued at the start and deposited in a box at the end of the trial - utilising a group system with maximum of 3 riders – no more than 3 riders to be present at any section – if found please wait at a suitable social distance - a one way system will operate through the section for inspection purposes again no more than 3 riders at a time, travelling marshals will circulate to ensure social distancing measures are being adhered to. Any displaced markers must be replaced by the rider wearing gloves, these will be disinfected at the end of the trial
- AWARDS:** Any awards at the discretion of the club.
- PETROL:** NOT AVAILABLE at the start.
- FINAL INSTRUCTIONS:** These may be given at the start.

- I understand that despite the precautions taken by the club and other riders, I may be exposed to the Covid-19 virus.
- I confirm that I am not unwell or suffering any symptoms of Covid-19 and will bring my own first aid kit for any minor injuries I may suffer
