- ENTRIES:** Open forthwith and must be made on the attached entry form and sent to the Secretary of the Meeting to arrive not later than, Start Time on the 17th December 2017. Together with the Entry Fee of Adult £ 18:00, Youth £15:00 S/Car £22:00
Cheques and Postal orders to be made payable to the **Normandy M C C**.
- COURSE:** Hookwood Trials Centre, Blakes Lane, West Horsley. Surrey. KT24 6EA
- MARKING:** Will be by the 0 - 1 - 2 - 3 - 5 T.S.R **22B NON STOP** system. All queries are to be taken up with the Clerk of the Course whose decision will be Final.
- AWARDS:** Adult, Expert: Inter, Novice, Pre 67, T/Shock, S/Person, Trail, O/50, Wobbler.
Youth: A-D Points will be given to Finishers in each class in order of finishing these to count to overall Championship positions when Awards will be given in each class at the end of the year.
- PETROL:** NOT AVAILABLE at the start.
- FINAL INSTRUCTIONS:** These may be given at the start.
