## SUPPLEMENTARY REGULATIONS

1. JURISDICTION: Held under the National Sporting Code of the ACU; the Standing Trials Regulations, Supplementary Regulations and any Final Instructions issued. The ACU National Sporting Code and Standing Regulations are published annually in the ACU Handbook.

2. ELIGIBILITY: Open to all Members of the Thames and Normandy Motor Cycle Clubs and Invited Guests – solos only

3. CLASSES: White Route = **Expert, Youth Expert**. Blue Route = **Inter, O/40, Youth Inter**. Red Route = **Novice, O/50, Pre 67, Twinshock, Youth Novice**. Yellow Route = **O/65, Sportsman, Youth Beginner**. Any Route = **Pic & Mix**.

THIS IS A STOP PERMITTED TRIAL – METHOD OF MARKING TSR 22A Scoring will be by individual score cards issued at the start and deposited in a box at the end of the trial utilising a group system with a maximum of 6 riders, a one way system will operate through the section for inspection with no more than 3 riders together. Travelling marshals will circulate to ensure social distancing measures are being adhered to.

4. ENTRIES: Via ACU on line system – limited to 60 – no day entries - no spectators

5. FEES: Adult = £20 Youth = £10 Opens 24th August Closes 16th September or when full

6. CHILD PROTECTION: The point of contact for Child Protection matters is the Secretary of the Meeting

7. AWARDS: Club Championship points only 8. COURSE: 4 laps of 10 Sections all on private land

I confirm that that despite the precautions taken by the club I maybe exposed to the Covid-19 virus. I confirm that I am not unwell or suffering any symptoms of the virus and will bring my own first aid kit for minor injuries.
